## **RULES COVERING THE USE OF ELECTRONIC DEVICES FROM THE DISTRICT**

You are receiving a device from the Dehesa School District so that you may use it only for educational purposes related to your attendance at the District and only for the educational programs of the District. The device is the property of the District and you are responsible for its safety and proper use.

Below is a comprehensive list of rules that you must carefully read covering the use of the device from the District. You are required to comply with all of these rules. Failure to comply with any rule may result in your having to return the device to the District.

1. The device is the property of the Dehesa School District and is not your personal property. Never leave it unattended where it might get stolen. Never take it out of its protective case. Never expose it to extremes in temperature or direct sunlight. Never lend your device to another person. The device is to be used by you for educational purposes only related to your attendance at the District and only for educational programs of the District.
2. The District has the right to check or examine the device at any time. You should have no expectation of privacy with regard to materials found on the device or your use of it. If you do not want the District to check or examine any personal materials or communications, do not place them on the District's device.
3. You are responsible for any damage or loss of the device. You must not attempt to repair the device if it fails to work properly or is damaged in any way. You must never disassemble the device. You must report any damage or loss immediately to the teacher.
4. The device you receive, plus any accessory, must be returned to the District at any time when requested by the District. If you graduate, withdraw, or terminate enrollment, you must return the device to the District immediately.
5. Any and all passwords for accessing the District's device must be registered with the teacher.
6. You are prohibited from deleting any District-installed applications or software. The addition of any application must have prior approval from the teacher. You are also prohibited from changing any setting or information on the device placed there by the District or in response to directions from the District without prior approval from the teacher.
7. The device may come equipped with a front-facing camera, rear-facing camera, and/or video capacities. You are not to record anyone or any group without their prior express permission. You shall respect the right to privacy of other students and employees. All recordings of any kind, videos, or photographs are the property of the District.
8. The device will be used in class and homework will be associated with the device. You are required to bring the device fully charged to school every day when onsite classes are in progress.
9. The device is to be used by you only for educational purposes and only for the educational programs of the District. While personalized screen savers or wallpapers may be used, obscene, pornographic, illegal, or threatening language or images are prohibited.
10. The district has a web filter in place for the device to assist in monitoring online activity and preventing users from navigating to inappropriate sites that may contain obscene, pornographic or other indecent material. Parents, guardians and students are responsible to ensure these types of sites are not visited at any time while using the device.
11. While remote learning is in place, you may take the District's device home for class work and recharging, but all of these rules apply wherever the device is located.

12. You are directly responsible for the care and maintenance of the device. You are required to use "reasonable care" to protect it. Never throw or slide the device. Never place the device in a book bag or any other bag that contains food, liquids, heavy objects or sharp objects. The device may be cleaned with a soft, slightly wet cloth. Follow all directions from the teacher with regard to the care and protection of the device.
13. Each device has a unique serial number and identification sticker that you must not modify or remove. Each device has the ability to be remotely located. You must not modify, disable or remove the locator, or in any way interfere with the District's attempts to locate your device.
14. If a device is lost or stolen or purposely damaged, you are responsible for repayment to the Dehesa School District in the amount of \$200.
15. Due date for the device to be returned to the District Office is June 9, 2023.

The District may add to this list of rules at any time. You are required to comply with all directives from the teacher with regard to the use of the device.
